The Heartland Cable Commission will be offering four (4) scholarships in the amount of \$1,500.00 each to eligible high school and non-traditional students planning on attending post-secondary school. These funds will be awarded through an open and fair selection process. There are no restrictions based on race, gender, religion, national origin, marital status, disability, or age.

Heartland Cable Commission Scholarship Criteria: (Check off List)

- _____ 1. Applicant must be a high school senior or a non-traditional student enrolled in an accredited post-secondary school.
- _____ 2. Applicant must have a 2.750 cumulative grade point average (GPA) or higher.
- _____ 3. **Applicant must live within the Heartland Cable Commission service area which includes these municipalities: (Pelican & Jenkins Townships or the Cities of Breezy Point, Jenkins, Pequot Lakes).**
- _____ 4. Applicant will carry 12 or more semester credits OR be considered more than a part-time student by the college he/she will be attending.
- _____ 5. Applicant must fully and neatly complete the Heartland Cable Commission Scholarship Application Form and attach a cumulative transcript with the application.
- _____ 6. Applicant must be willing to participate in a short interview if deemed necessary by the Heartland Cable Commission Scholarship Committee.
- _____ 7. Applicant must submit the Application Form and transcript to the high school counselor's office before: **April 15, 2015 at 4:00 P.M.** Non-Traditional applicants may submit their application directly to the Heartland Cable Commission at the address noted herein.

Additional Information:

The scholarship award will be delivered via check to the accredited post-secondary school of the student's choice after verification from the registrar's office of the student enrollment in a post-secondary program of study. The funds may be used for tuition and fees related to education. The scholarship money may be distributed according to the post-secondary school's guidelines (i.e. split between semesters or quarters).

All scholarship awardees will be informed of their status regarding the Heartland Cable Commission Scholarship. Applicant acknowledges that not everyone who applies will be awarded a scholarship. The applicant agrees to abide by the final decision of the Heartland Cable Commission Scholarship Committee.
