

**Pelican Township  
Regular Meeting Minutes  
February 10, 2026 7:00 PM**

**In Attendance:** Supervisors –Giles Radtke, Micheal McDaid, Dave Truchan, Treasurer – Alisha Wallin, Clerk – Jody Wallin (digitally), BPPD Dan Sathre, Brad Harrington (Plow Driver)

Radtke called the meeting to order at 7:00 PM. All stood and recited the pledge of allegiance.

**Police Report Breezy Point** – Officer Sathre read thru the written report – 18 calls, pretty normal for the time of year. Radtke mentioned if officers found areas of concern for salt sand to message him and he will get plow driver out.

**Public Comment** – Plow Driver – Brad Harrington just checking in to make sure there was no concerns etc. None were given.

**Approval of Minutes** – McDaid made a motion to approve the January 8, 2026 Regular Meeting Minutes, Truchan seconded, none opposed - motion carried. McDaid made a motion to approve the January 8, 2026 Audit Meeting Minutes, Truchan seconded, none opposed - motion carried

**Treasurer's Report** – Wallin presented the Treasurer's report as of January 31, 2026. Beginning balance \$412,139.51, receipts \$33,111.09, disbursements \$9,415.18, ending balance \$435,835.42. FNB North CD \$242,997.58 and First Western CD \$140,840.89 Giving overall operating and investments of \$819,673.89. Wallin talked to both First Western and First National Bank as CD's come due end of the month – rates are estimated to be around 3.5%, she will talk with them and negotiate as possible. Will get collateral info as needed from FNB North. McDaid made motion to approve the Treasurer's Report, Truchan seconded motion, Roll Call Vote – Radtke – aye, McDaid – aye, Truchan – aye, none opposed – motion carried.

**Bills were presented for Payment** – McDaid made motion to pay all bills as presented as well as the Pequot Lakes/Breezy Fire Contract, Truchan seconded motion, Roll Call Vote – Radtke – aye, McDaid – aye, Truchan – aye, none opposed – motion carried.


McDaid made a motion to adjourn at 7:51 pm, Radtke seconded, non-apposed, meeting adjourned.
