

**Pelican Township
Regular Meeting Minutes
July 8, 2025 7:00 PM**

Bills were presented for Payment – Treasurer Wallin presented the bills for payment. The Board reviewed bills and signed checks. McDaid made motion to approve bills as presented, Truchan seconded motion, Roll Call Vote – Radtke – aye, McDaid – aye, Truchan – aye, none opposed – motion carried.

New, Old and Other Business –



Next Regular Board Meeting – moved to Monday August 11, 2025 at 7:00 PM.


