

**Pelican Township
Regular Meeting Minutes
September 9, 2025 7:00 PM**

Radtke called the meeting to order at 7:00 PM. All stood and recited the pledge of allegiance.

Police Report Breezy Point – Officer Garbe read the written report. No additional information or updates.

Approval of Minutes – McDaid made a motion to approve the August 11, 2025 Regular Meeting Minutes, Radtke seconded, none opposed - motion carried.

Treasurer's Report – Wallin presented the Treasurer's report as of August 31, 2025. Beginning balance \$615,704.05, receipts \$6336.45, disbursements \$15,150.09, ending balance \$606,890.41. FNB North CD had interest payment of \$2,694.72 for ending balance of \$240,272.30 and First Western CD \$140,840.89 McDaid made motion to approve the Treasurer's Report, Truchan seconded motion, Roll Call Vote – Radtke – aye, Truchan – aye, McDaid – aye, none opposed – motion carried.

Bills were presented for Payment – Treasurer Wallin presented the bills for payment. The Board reviewed bills and signed checks. McDaid made motion to approve bills as presented and if needed – to cut an additional check to Anderson Bros for \$21,630.45 to cover Breezy Points portion of Edge Water Circle Bill and have them reimburse us – Radtke will follow up, Truchan seconded motion, Roll Call Vote – Radtke – aye, McDaid – aye, Truchan – aye, none opposed – motion carried.

New, Old and Other Business –


